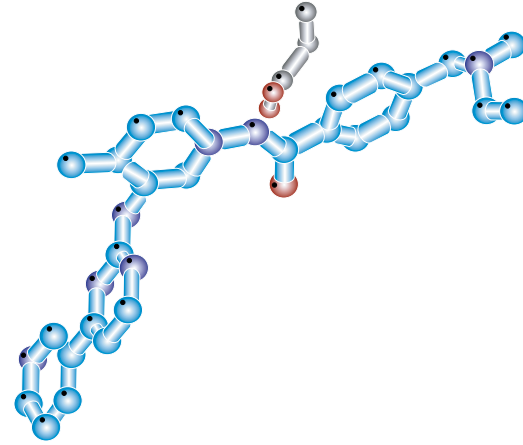

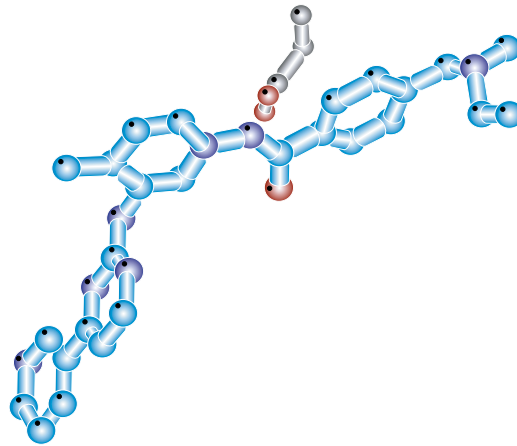

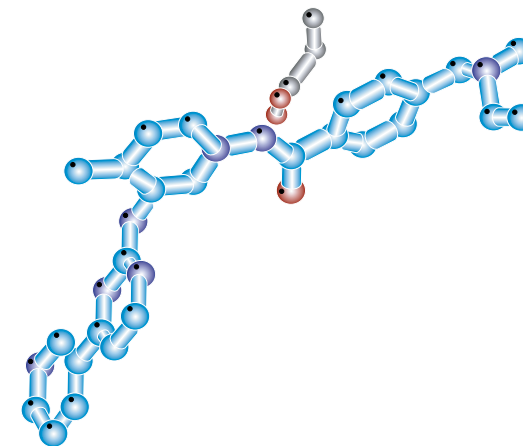

INFORMATION ON LEGISLATIVE DECREE N. 196/2003

According to art. 13, Legislative decree no. 196/2003, and in relation to the processing of personal data, Triumph Viaggi & Incentive S.r.l inform you of the following:

1. Data processing purposes

Your personal data will be processed by Triumph Viaggi & Incentive S.r.l. for managing, accounting, statistical, commercial, marketing and/or promoting purposes and this by processing, comparing, divulging or employing these very data.

2. Data Processing modality

Data will be processed by appropriate devices ensuring their security and confidentiality. Data could be also processed by automatic machines employed to process, store and transmit the very data.

3. Obligatoriness of personal data bestowal

To be registered in the congresses we organize, you are obligated to give your data.

4. Data communication, diffusion and transfer

5. Rights of interested parties

Furthermore you can prevent his data from being used for commercial purposes, market surveys, advertisement for direct selling or interactive commercials. You are acknowledged exercise of rights as per art. 7, Legislative decree 196/2003, the complete text of which is given in the enclosure.

6. The owner of the data processing

Article 7 of the legislative decree 196/2003 – right of access to personal data and other rights

2. The person concerned is entitled to be informed of:

- the origin of personal data and information;
- data treatment purposes and ways;
- the logic followed in the event of data treatment being carried out with electronic tools;
- the details to identify the owner, the persons in charge and the representative appointed under article 5, paragraph 2;
- the people or groups of people to whom personal data and information can be disclosed or who may come to know them in their capacity as representative appointed in the State territory or persons in charge.

3. The person concerned has the right to obtain:

- updating, correction or – where interested in this process – supplementation of data;
- cancellation, turning into anonymous data or the block of data treated by infringing the law, including data and information which need not be kept in relation to the purposes for which data and information were collected or subsequently treated;
- a certificate stating that the operations under sub-paragraphs a) and b) - including their content – have been communicated to those to whom data and information were provided or disclosed, except the case when this proves to be impossible or entails the use of such an amount of means which is overtly non commensurate with the right which is protected.

4. The person concerned has to right to wholly or partially refuse:

- treatment of personal data and information regarding him/her for legitimate reasons, even though they are relevant to the aim of collection;
- treatment of personal data regarding him/her for the purposes of sending advertising material, direct sale or performance of market studies or commercial communications.
